

## Terms and Conditions of Using the ArtThread Online Gallery

### 1. Your Acceptance

A. By using and/or visiting this website (collectively, including all content and functionality available through the ArtThread.org domain name, the "ArtThread Interactive Online Gallery", or "ArtThread"), you signify your agreement to these terms and conditions (the "Terms of Service"), and to ArtThread's privacy notice, found [here](#). If you do not agree to any of these terms, or the ArtThread privacy notice, please do not use the ArtThread Website.

B. Although we may attempt to notify you when major changes are made to these Terms of Service, you should periodically review the most up-to-date version. ArtThread may, in its sole discretion, modify or revise these Terms of Service and policies at any time, and you agree to be bound by such modifications or revisions. Nothing in this Agreement shall be deemed to confer any third-party rights or benefits.

### 2. ArtThread Online Gallery

A. These Terms of Service apply to all users of the ArtThread Website, including users who are also contributors of art content, information, and other materials or services on the Website.
